T	nis ATTORNEY-CLIENT AGREEMENT ("Agreement") is entered into by and between
	(Client) and ZHANG & ASSOCIATES, P.C. (Attorney).
1.	SCOPE AND DUTIES : Client retains Attorney to provide legal services in connection with the filing of the Naturalization Application (N-400) for
	(Beneficiary) ONLY. Attorney is not retained for service on appearing in person with Client for
	Naturalization interview. An independent agreement is needed for services other than the N-400
	Application. Attorney will be responsible for preparing the document package and all legal forms.
	This Agreement does not obligate Attorney to provide services in connection with any appeal to an administrative board or any judicial courts.
2.	GUARANTEE OF PROFESSIONAL COMPETENCE: Attorney agrees to use due diligence
	in furthering Client's and/or Beneficiary's best interests under the laws. Attorney is liable to Client
	for Attorney's negligence or incompetence. However, Attorney makes no guarantee of the outcome of the case.
3.	LEGAL FEES : Client agrees to pay for the legal services as follows: Upon the execution of the Agreement, Client shall pay non-refundable One Thousand Dollars (\$1000.00) flat attorney fees to Attorney. These cover all legal fees and costs Attorney may have in connection with the original application for Client, except as is otherwise provided herein.
4.	MODIFICATIONS : Any modification of the Agreement must be in writing and signed by Client and Attorney.
5.	PRIOR AGREEMENTS : This Agreement incorporates all prior agreements and understandings between Client and Attorney.
6.	EFFECTIVE DATE : This Agreement shall become effective when both Attorney and Client significant upon Attorney's receipt of the fees as listed in clause 3 above.

- 7. **GOVERNING LAW AND JURISDICTION**: This Agreement shall be governed and construed under the laws of the State of Texas. Client consents to the jurisdiction of the State of Texas as the exclusive jurisdiction, and Harris County, Texas as the exclusive jurisdiction, for any litigation regarding this Agreement.
- 8. **FILING FEES**: Client agrees to pay all government filing fees to Zhang & Associates, P.C. at the time of filing, including, but not limited to:

N-400 Filing Fee: \$640 per person

USCIS Biometrics Fee: \$85 per person
